OUR LEAGUE PRESIDENT, SENDS A MESSAGE TO THE CITY: CREATE AN “E-BULLETIN BOARD”

The following letter was sent to the Mayor and each of the members of the Escondido City Council on March 9, 2009

The week of March 15th-21st marks Sunshine Week, a non-partisan National initiative started after 9/11 to promote open government and freedom of information. One of the stated goals of Sunshine Week is “to enlighten and empower people to play an active role in their government at all levels, and to give them access to information that makes their lives better and their communities stronger.”

Historically, the League of Women Voters has supported the informed and active participation of voters at all levels of government, and has recently been an active supporter and co-sponsor of Sunshine Week activities. The League believes that “government bodies should give adequate notice of proposed actions, hold open meetings and make public records accessible.”

In keeping with League principles and the goals of Sunshine Week, the League of Women Voters of Escondido and Neighboring Communities would like to propose a way for the City of Escondido to better serve and inform its residents.

Currently, Escondido provides a variety of information about city services, including live video streaming of City Council meetings, and several online registration forms on its website. However, many Escondido residents have noticed a gap in the information provided on the city’s website when it comes to the advance posting of Modified Agendas, Meeting Cancellation Notices, Notices of Scheduled Vacancies, Board and Commission Appointment Lists, Special Appointments, etc. These items are always posted in advance in “hard copy” form on the bulletin board that stands in the City Council Chamber’s rotunda but do not appear in advance (some not at all) on the website.

Our suggestion is that the City of Escondido establish an “E-Bulletin Board” on its website that effectively carries the same information

as that which is posted in hardcopy on the bulletin board outside Council Chambers. This “E-Bulletin Board” will provide a virtual “snapshot” of any and all posted announcements and will keep residents informed in a timely manner. It will also save them time and gas, and a trip to city hall in this rough economy. A dynamic “E-Bulletin Board” will mark Escondido as a city of progress with an enhanced interest in strengthening community outreach and civic engagement.

We hope you will accept this idea in the spirit of good government. Thank you for your consideration.
