LWVC SUPPORTS THE VOTERS FIRST ACT:

Background: What is redistricting?

- Every 10 years, after the census, new boundary lines for Congress and CA Senate, Assembly and Board of Equalization districts are drawn. Currently, the CA State Legislature draws those lines. This is a major conflict of interest.

How would California Voters FIRST Act change redistricting?

- **14-Person Citizens Redistricting Commission.** The California Voters FIRST Act would create a politically balanced Commission - 5 Democrats, 5 Republicans, 4 others. Commissioners would be chosen for their impartiality, skills, and to reflect our State's demographic and geographic diversity.

- **Protecting communities, cities, and counties.** The California Voters FIRST Act would create a list of prioritized mapping criteria for the Commission to follow. This would ensure that our Constitution, federal and state laws are followed. California's communities, cities, and counties must be respected.

- **Open and public process.** The Commission would hold hearings to receive public input. The California Voters FIRST Act would end the closed-door political deals by legislators to draw districts that protect themselves.

How would the Commission be formed?

- California registered voters are invited to participate.
- A pool of 60 (20 Ds, 20 Rs, 20 others) is selected based on their skills, ability to be impartial, and diversity by a review panel of state auditors (1D, 1R, 1 other).
- The 4 Legislative Leaders can strike up to 24 people from the pool.

- Out of the remaining pool, 8 Commissioners are randomly picked - 3 Ds, 3 Rs, 2 others.

- The final 6 Commissioners (2 Ds, 2 Rs, 2 others) are chosen by the 8 Commissioners from the remaining pool based on the balance of skills and diversity they would bring.

What Mapping Criteria would the Commission have to follow? In ranked order, the criteria are:

- a. Districts shall comply with the US Constitution, including equal population requirements.
 - b. Districts shall comply with the Voting Rights Act.
 - c. Districts shall be geographically contiguous.
 - d. The geographic integrity of any city, county, or city and county, neighborhoods, or communities of interest shall be respected. Communities of interest shall not be defined as having a relationship with incumbents, candidates, or parties.
 - e. To the extent possible, after the above criteria have been satisfied, districts shall be compact.
 - f. To the extent possible, after the above criteria have been satisfied, districts shall be nested.
- * *Incumbent residences may not be considered; districts may not be drawn to favor politicians or parties.*



What is the scope of the Citizen's Redistricting Commission?

- The Commission will draw California Senate, Assembly and Board of Equalization seats in the next redistricting, 2011 and after each decennial census.
- The State Legislature will draw Congressional seats, following the same mapping criteria and hearing requirements as the Commission.

LWV SAN DIEGO COUNTY OPPOSES SUNRISE POWERLINK PROJECT:

On April 7, 2008, Nancy McCleary, President of the LWV of San Diego County wrote to Dian Grueneich, Commissioner of the California Public Utilities Commission to state the County League's opposition to "all of the proposed transmission line routes that would run through the Anza Borrego Desert State Park."

Nancy cited the 1975 LWVUS adopted position supporting adoption of a national energy policy that includes conservation. The LWVC's recently updated energy policy states: "regulatory and planning agencies as well as the energy providers, should give primary consideration to conservation and energy efficiency. State regulation and planning agencies, as well as the energy providers, should give primary consideration to conservation and energy efficiency"

She also cited the California League's position on planning for transmission lines: "the state should implement an integrated energy planning process that establishes consistent statewide procedures for the set-aside of land that will be needed for future transmission corridors and other associated energy infrastructure, in compliance with California Environmental Quality Act (CEQA) requirements." That would obviously "preclude SDG&E from running new lines through the Anza Borrego Desert State Park

Nancy noted that the LWV of the city of San Diego, voted to support "the current San Diego Association of Government's (SANDAG's) Regional Energy Strategy, calling for increasing the amount of in-basin energy resources to meet the area's growing peak demand instead of depending on fossil fuel power imported from far away regions." She also noted that "SB 1039 (Kehoe) requires the CPUC and the local utility exhaust all viable and cost effective energy efficiency, demand response, renewable energy and customer distributed generation alternatives within the region before considering new fossil fuel generation and associated transmission projects. III. LWVC Positions on the June 2008 Ballot Measures

The June 3, 2008 ballot features two propositions on the subject of eminent domain. The first, Proposition 98 is similar to Proposition 90, which the LWVC opposed on the November 2006 ballot. However, it goes much farther in limiting the ability of public agencies to acquire land to provide water resources, to regulate land use, to protect natural resources. It contains provisions that would eliminate rent control and other renter protection laws, such as laws requiring the fair return of rental deposits and laws requiring 60-day notice before forcing tenants out of their housing. Although its proponents claim it is about eminent domain reform, its hidden agendas and flaws in drafting would actually hurt Californians. The League **OPPOSES Proposition 98**, and has signed the ballot argument against the measure.

The second, Proposition 99, The Homeowners Protection Act, simply addresses a recent U.S. Supreme Court decision by clarifying that single-family occupied properties may not be condemned for transfer to other private parties. It recognizes the right of local governments and others to regulate land use and to acquire property for valid government purposes.
