## IMMIGRATION STUDY CONSENSUS MEETING

As has been reported in previous editions of *The Voter*, the LVWUS is in the process of studying the U.S. immigration problem. As you know, the process of study and coming to consensus is a time-honored League process by which we arrive at a position on issues important to our democracy. It is vitally important that all leagues participate in the consensus process so that the League's position will be soundly based on our members' views. To that end your local league held a General Meeting on January 12, 2008 to consider the questions and options being studied. Attendance was very good with 35 members participating. League members Margaret Liles, Judge Patrick Coony, Fred Scott, Arlene Meadows and Elizabeth Gabrych did an excellent job in reviewing the immigration study papers that were provided by LVWUS. Following their presentations, we were then asked to assign "high priority", "lower priority", "disagree" or "no consensus" to each criterion that was being considered.

After much discussion and stimulating exchanges of ideas, the following results were recorded:

**Question 1:** Federal immigration laws should take into consideration criteria such as the following: (a) ethnic and cultural diversity – no consensus was reached; (b) economic, business and service employment needs – high priority was assigned; (c) environmental impact/sustainability – high priority was assigned; (d) family reunification of authorized immigrants and citizens with spouses and minor children – no consensus was reached; (e) history of criminal activity – high priority was assigned; (f) humanitarian crises/political persecution in home countries – no consensus was reached; (g) immigrant characteristics (health and age) – high priority was assigned; (h) rights of all workers to safe working conditions and livable wage – disagree; (i) right of families to remain together – disagree; (j) rights of all individuals in U.S. to fair treatment under the law (fair hearing, right to counsel, right of appeal and humane treatment) – no consensus was reached; (k) education and training – lower priority was assigned.

We were then asked to choose the three most important criteria we had marked as high priority. We chose (1) history of criminal activity; (2) environmental impact/sustainability and (3) economic, business and

service employment needs.

**Question 2** discussed enforcement issues for illegal immigrants currently in the U.S. This problem was discussed at length with varying degrees of concerns being expressed but we were unable to reach consensus on any of the options presented. However, we were in unanimous agreement that members of Congress must be vigorously lobbied to resolve the problem of what to do with the current illegal immigrants residing in this country since that is a job for which they were elected to do.

**Question 3:** Federal immigration law should provide an efficient, expeditious system for legal entry into the U.S. for immigrants who are: (a) immediate family members joining family member already admitted for legal permanent residence in the U.S. – no consensus was reached; (b) entering the U.S. to meet labor needs – high priority was assigned; (c) entering the U.S. as students – lower priority was assigned; (d) entering the U.S. because of persecution in home country – high priority was assigned.

**Question 4a:** In order to deal more effectively with illegal immigrants, Federal Immigration law should include: high priority was assigned to requiring a social security card or other national identification card with secure identifiers for all persons residing in the U.S.

**Question 4b:** Federal immigration law dealing with illegal immigrants should be enforced by – high priority was assigned to establishing a more effective tracking of persons with non-immigrant visas until they leave the county; verification of documents, such as green cards and work permits with secure identifiers; improved technology to facilitate employer verification of employee visa status; improved technology for sharing information among federal agencies; a program to allow immigrant workers to go in and out of the U.S. to meet seasonal and sporadic labor needs; and significant fines proportionate to revenue for employers who fail to take adequate steps to verify work authorization of employees.

**Question 5:** We reached consensus that federal immigration law should address and balance the long-term federal financial benefits from immigrants with the financial costs borne by state and local governments with large immigrant populations.

**Question 6:** We were unable to reach consensus regarding whether or not federal immigration law should be coordinated with U.S. foreign policy to pro-actively help improve economies, education, job opportunities and living conditions of nations with large emigrating populations.

The deadline for submitting the consensus question responses was February 1, 2008. Our league's response was submitted electronically to LWVUS on January 14, 2008. It is my understanding that the

LWVUS Immigration Study Committee will formulate the League position from February 1 to March 20, 2008. In early April 2008, it is anticipated that the LWVUS Board will consider the committee's recommendation and formally adopt the League's position; it will then be announced to members and the public.

## REDISTRICTING INITIATIVE:

The LWVC has joined Governor Arnold Schwarzenegger, California Common Cause, AARP, and the Los Angeles Area Chamber of Commerce in launching a campaign to place a redistricting initiative on

the November 2008 ballot. The California Voters FIRST initiative will reform the process of redrawing district line for the state Senate, Assembly and Board of Equalization following each census.

At a press conference on December 3, LWVC President Janis R. Hirohama said:

"This proposal meets all the criteria that the League of Women Voters wants to see:

- **An independent citizens commission that has members who are qualified, balanced among the major parties while providing for others to participate, and representing the diversity of our state's population.**
- **Clear criteria, in priority order, for establishing districts – not only abiding by the U.S. Constitution and the federal Voting Rights Act, but also recognizing communities of interest and the political boundaries of cities and counties**
- **An open and public process.**

She concluded, "League of Women Voters members around the state will work enthusiastically to help qualify this initiative and see that it is passed by the voters next November."
